Examples include a quiz, an extremely interactive class discussion, a warm-up, a closure, or an exit slip. It needs to encourage individuals to take part in the testing. It needs to be open, inclusive, and consistent with expectations.

A methodology or method of analyzing information to ascertain how much someone understands and whether this knowledge fits into the overall framework or theory is known as an assessment tool.

The setting and objective affect which assessment techniques are used. Financial assessments, for instance, evaluate your knowledge of concepts like saving and investing, while personality tests use your replies to identify character traits. Assessment tool must be reliable, valid and standardized.

A strategy or method of evaluating information, an evaluation tool has the following characteristics:

- *A decent assessment tool ought to have a window for useful criticism.*
- *It is doable and takes equivalency into account.*
- *It needs to encourage individuals to take part in the testing.*
- *It ought to be open, inclusive, and consistent with expectations.*

A "Teachers who use assessment FOR learning" engage their pupils in continuing self-evaluation in methods that show learners (a) where they are headed in their learning, (b) where they are at the moment in reference to those expectations, and (c) how each pupil may close the gap between the two."
