



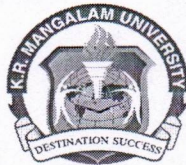

1.01 To review the Code of Ethics for research in university

Committee members reviewed the code of ethics for research, approved in research promotion policy dated 26 April 2022. After reviewing the committee recommended to include the new plagiarism software "Drillbit" in addition to URKUND for checking similarity of PhD theses/PG/UG Dissertations/Publications/Projects/etc prior to acceptance for evaluation.

Members noted the same as per annexure-I

1.02 To review the adherence to the UGC guidelines and procedures for use, storage and safe disposal of chemicals, experiments on animals and use of radioisotopes and safe disposal of bio and radio waste.

Committee members suggested to strictly adhere to the UGC guidelines for Procurement and Usage of Radioisotopes, Additional requirements for laboratory irradiators, X-Ray generators and neutron sources, Standard Operating Procedures (SOP) handling and usage of radio isotopes, hazardous chemicals/materials, Radiation instrument/survey/reporting, Disposal of radioisotopes, Emergency preparedness for institutions handling sealed/ unsealed sources and gamma chamber, Handling of Hazardous Chemicals and do's and do not's during an emergency in a chemical lab, Measures to respond to a chemical emergency, Impact of exposure to chemicals on human beings, Biological/biotechnological laboratories

Committee also discussed all the points in last Institutional Animal Ethic Committee (IAEC) meeting held on 29-10-2021 and appreciated the efforts of the committee and suggested to ensure conduct of the IAEC meeting as stipulated in the SOP and suggested to furnish the Annual Inspection Report of the Animal House Facility regularly to the O/o CPCSEA. Our establishment has been registered with CPCSEA for the purpose of 'Small animal:- Research for Education with Registration number is 1956/PO/Re/S/17/CPCSEA.


Layout design of animal store was reviewed by committee members and was found to be in agreement by CPCSEA guidelines. Committee members suggested to complete all necessary steps required for the conduction of inspection of the Animal House Facility of KRMU establishment within due period which is urgently needed for renewal of registration with CPCSEA for the term of next five years. These requirements were pre-sent by Member Secretary (CPCSEA) on 27th June 2022.

All members noted the same as per annexure-IIIa- IIIId.


